WILDERNESS PROTECTION: UPGRADING STATUS OF PUBLIC LANDS IN FY 2015, OUR GRASSROOTS ORGANIZING WORK SUCCESSFULLY MOBILIZED THOUSANDS OF WILDERNESS ADVOCATES TO STAND UP FOR NEW MEXICO'S WILD PUBLIC LANDS. IN DECEMBER 2014, THE COLUMBINE HONDO WILDERNESS WAS DESIGNATED, PROTECTING 45,000 ACRES OF THE SANGRE DE CRISTO MOUNTAINS IN NORTHERN NEW MEXICO. WE ANNOUNCED OUR INTENTION TO SECURE WILD AND SCENIC STATUS FOR THE GILA RIVER; PLANS TO EXPAND THE PECOS WILDERNESS; AND STEPS TO PROTECT WILDERNESS WITHIN THE RIO GRANDE DEL NORTE AND ORGAN MOUNTAINS DESERT PEAKS NATIONAL MONUMENTS.
